Volume Indices

National Accounts Estimates for 2022 - 2023

The Central Administration for Statistics (CAS) releases in this document the Gross Domestic Product (GDP), Gross National Income (GNI) and Gross National Disposable Income (GNDI) estimates for 2022 and 2023, including revised series. It also includes the activity and the expenditure components of GDP.

Highlights:

GDP at current market prices was estimated in 2023 at 2760.6 trillion Lebanese Pounds (LBP) and in 2022 at 651.2 trillion Lebanese Pounds (LBP). These values are following a 2021 GDP of 254.8 trillion LBP. Similarly to the 2020 and 2021 estimates, the 2022 and 2023 estimates include the effects of the rapidly rising prices.

In addition, the National Accounts estimates of 2020, 2021 and 2022 take into account an implicit net subsidy resulting from the operation of multiple subsidized exchange rates. A weighted average exchange rate per USD is converted on a yearly basis (see the note on the exchange rates used in the national accounts for details). It is used in the calculation of the yearly GDP in USD for the years 2020-2022.

The nominal GDP in 2023 is 31.6 billion USD, slightly up from respectively 21.4 and 20.1 billion USD in 2022 and 2021. The 2023 GDP value represent around 59% of the 2019 level of 53.3 billion USD.

In real terms, it is estimated that GDP at constant prices increased slightly, by a minimal percentage change of 0.5 per cent, in 2023, following a relatively better condition manifested by respectively 1.8 per cent, and 2.1 expansion in 2022 and 2021.

It is important to note, that these growth rates follow an economic contraction summarized by a shrink in 2020 GDP, with a negative growth rate of 26.8 per cent in that year.

GDP at constant prices in 2023, is still only 76 per cent of the 2019 level, reflecting the relatively tough conditions experienced by the Lebanese economy since that time.

The inflation rate in the domestic economy, as measured by the GDP deflator, was 321.8% in 2023, and 151.1% in 2022 following a rate of 172.2% in 2021.

In 2023, Gross National Income (GNI) was 2752.3 trillion LBP (31.5 million USD) while Gross National Disposable Income (GNDI) at current prices registered 3272.3 trillion LBP (37.4 million USD). GNDI exceeds GDP in Lebanon. This is because the GNDI includes remittances from Lebanese expatriates among other transfers. However, the two components became closer after the crisis.

BOX 1: DEFINITIONS

Gross Domestic Product (GDP) is the value of the goods and services produced by the nation's economy less the value of the goods and services used up in production (known as 'the Production approach' to measurement). CAS uses the production approach to calculate GDP.

GDP is also equal to the sum of final consumption expenditures (households and government), gross fixed capital formation (private and public) and net exports (Exports minus Imports) of goods and services, (known as the Expenditure approach).

Basically, GDP measures the value added of all resident producers - as such, it is also equal to the sum of the primary incomes (compensation of employees and property income such as interest, dividends and other...) that accrue to units as a consequence of their, direct and indirect, involvement in production.

BOX 1: DEFINITIONS- continued


The Goss National Income (GNI) is a more specific concept of income, since it adds to the value of GDP, the primary incomes (mainly interest and dividends) receivable from non-resident units, while primary incomes payable to non-resident units are deducted.

The Gross National Disposable Income (GNDI) represents a step further in the distribution of income. It is equal to GNI less current transfers (remittances and other transfers) payable to non-resident units, plus the corresponding transfers receivable by resident units from the rest of the world. Gross National Disposable Income measures the income available to the total economy for final consumption and gross saving.

The figures for primary incomes and current transfers with the rest of the world are derived from the Balance of Payments statistics issued by Banque du Liban.


Chart 1 shows the values of GDP in both current and constant 2019 market prices (real terms) since 2011.



BOX 2: INFORMAL AND UNRECORDED ACTIVITY

In Lebanon, as in many countries, some activities are carried out by the "informal sector" and some other economic activities are also difficult to measure routinely, if at all. However, allowances have been included in the official estimates presented here (amounting to around 30% of recorded output) to cover the value of such activity, although by definition the level remains uncertain.

Inflation, as measured by the GDP deflator, scored 321.8% in 2023, compared to 151.1% in 2022.





BOX 3: PRICES OF THE GDP and PRICES OF ITS COMPONENTS

The GDP deflator is an indicator of price inflation within the domestic economy as a whole. It is what is known as an implicit deflator. It is calculated by comparing GDP at current market prices with GDP in volume terms, rather than being directly measured like consumer prices.

The relationship between the deflators is best understood by considering inflation in the total supply of goods and services and in their use. Inflation in the supply is a weighted average of imports and GDP, while inflation in the use is a weighted average of the final expenditures.

In 2023, the GDP implicit deflator increased by 321.8% while that of imports increased by 163.3%

The implicit deflators of the final expenditures were as follows:

- Household final consumption expenditure 268.2%
- Government final consumption expenditure 281.1%
- Gross capital formation 196.3%
- Exports 188.8%

The GDP deflator specifically excludes imported price changes. Changes in the final consumption expenditure deflator may be expected to be close to the changes in the average CPI for 2023 compared with that for 2022 (221.3%). However, differences may arise for several reasons. First, final consumption expenditure is measured indirectly as a residual in the Lebanese national accounts. Many assumptions are made in its compilation. Secondly, some of the price information used may not be wholly compatible with that from the CPI. Thirdly, the CPI is compiled using fixed expenditures on a basket of goods and services, as measured in the Household Budget Survey in 2011. Thus, the information and compilation procedures are completely different. The economic crisis may cause a larger difference between the 2 components, than in a stable economic condition.

Notes on the tables

In most cases percentage changes on the previous year are also given, though in some cases where appropriate, the percentage figures are shares of total GDP or gross value added (GVA) rather than year on year changes.
